

2018 CHEEZ-IT BOWL CARL'S JR. TWITTER GIVEAWAY

Promotion begins on December 22, 2018 at 12:00 p.m. local Arizona time and ends on December 24, 2018 at 05:00 p.m. local Arizona time (the "Promotion Period"). Sponsor's computer is the official time keeping device for this Promotion.

1. **ELIGIBILITY:** The 2018 Cheez-It Bowl Carl's Jr. Twitter Giveaway Promotion (the "Promotion") is open to legal U.S. residents currently residing in the 50 United States and the District of Columbia (excluding Rhode Island) who are at least eighteen (18) years old, nineteen (19) in Alabama and Nebraska, or twenty-one (21) in Mississippi, as of the date of Promotion entry. A. **SOCIAL MEDIA ENTRY:** Promotion must be entered by following @CheezItBowl on Twitter, posting a video and tagging the Cheez-It Bowl's Twitter account.

Inappropriate comments, photos, messaging, etc. will result in immediate disqualification at the discretion of Sponsor.

B. **MAIL-IN ENTRY:** mail a 3X5 card to Valley of the Sun Bowl Foundation/c/o Cheez-It Bowl Twitter Promotion at 7135 East Camelback Road, Suite 190, Scottsdale, Arizona 85251.

For purposes of this Promotion, each social post or mail-in entry that you send pursuant to the above directions constitutes one (1) entry. Limit: one (1) entry per person. No automated entry devices, bots and/or other programs and/or software are permitted for entry.

Entries must be submitted by the entrant. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human, or electronic. Sponsor shall not be responsible for incorrect or inaccurate entry information

whether caused by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of the entries in the Promotion.
