

2018 PLAYSTATION® FIESTA BOWL INSTAGRAM GIVEAWAY

B. **MAIL-IN ENTRY:** mail a 3X5 card to Arizona Sports Foundation c/o PlayStation® Fiesta Bowl Instagram Promotion at 7135 East Camelback Road, Suite 190, Scottsdale, Arizona 85251.
